

# Equality and Diversity Data

Chambers has an ongoing commitment to the fair and equal treatment of all members, pupils and staff. As part of this commitment (and in compliance with the requirements of the Bar Standards Board (BSB) Code of Conduct) Chambers has undertaken a diversity survey of all its barristers and staff. This report summarises and publishes the results of that survey.

#### The basis of the survey

- All members, staff and pupils were given the opportunity to provide their Diversity Data via an online survey in August/ September 2023.
  - The provision of such data was entirely voluntary and individuals were free to provide some, none or all of their Diversity Data.
- 86 out of a total of 142 responded to the survey. Of those, 76 gave consent for their answers to be published. This is a response rate of around 60%.
- · Data was collected anonymously.
- Data is not published where its publication might otherwise lead to the identification of individuals. Where figures in any
  category are below 10, they are only reported where consent was given by all individuals in the category. Otherwise, the
  category may be removed in its entirety, may be merged with another category to give a broader view or a headline
  summary may be given in its place.
- Where percentages are given, they are percentages of the total number of actual respondents to the survey and not percentages of the workforce as a whole.
- For brevity, the summary below only includes positive results (ie where there were no people under the age of 25, the table does not include a category for people under the age of 25).
