JUDICIAL ANNOUNCEMENTS AND UPDATES FROM COURTS

- Jury trials have begun in four court centres, including Manchester's Minshull Street Crown Court, in the very safe hands of Peter Cadwallader (see above). Mr Justice Edis has provided an early update on the progress being made across the country.
 Read it here. One trial per court centre at the moment, but three more buildings are likely to start trials soon, although none in the North. Watch this space.
- Of course, none of us want to be in court unless it's safe for our clients, for our colleagues, for us and for everybody else. Deputy Head of Chambers and Attorney-General of the Northern Circuit, <u>Jaime Hamilton QC</u>, joined the Circuit Leader in a meeting with our senior judges to represent the views of the team on the safe restart of trials. The meeting led to some strong reassurances being given to all court users about the importance of their safety read the response <u>here</u>.
- Through all of this hard work, courts *are* sitting, and everybody will understandably be anxious. If you or your clients have to go to a court building, there is official government guidance on keeping safe. It is well worth a read. Do so here.

(CLOUD) VIDEO NASTIES

- Most of us working in the criminal justice system have now got used to video-based platforms of one form or another. But we are soon going to be getting to grips with "CVP" "Cloud Video Platform" as the default method of conducting remote hearings. The Northern Circuit have a helpful guide available here.
- The team are working hard to get ahead of the curve with CVP before it comes online properly. <u>Nigel Booth</u>, <u>Nicola Gatto</u> and <u>Hayley Bennett</u> have been in training and are pulling together some bespoke guidance to get us all up to speed.
