#### CRIMINAL JUSTICE UPDATES

A Covid 19 working party has been set up by the senior judiciary with a view to commencing jury trials as soon as it is safe to do so;

**Liverpool Crown Court** issued further guidance notes on the 22<sup>nd</sup> April 2020. Currently there will be no jury trials listed. However, parties must continue to prepare pending trials given the continuously changing landscape. This includes maintaining contact with defendants and communicating with witnesses;

Preston Crown Court are now considering the re-listing of trials up to the 15th May 2020. It is proposed that custody and vulnerable

witness cases will be listed as 'priority fixed floaters' in October 2020 and as fixtures in December 2020. Bail cases will be re-fixed early in 2021. Most cases will be listed for mention in the next couple of weeks to see if they are capable of resolution. (N.B. Our team members are actively reviewing their own caseloads. Should you require a conference with instructed counsel please contact us. We have facilities to arrange for any client currently on bail to attend chambers and participate in a remote conference with solicitor and counsel. Manchester and Liverpool Crown Courts are now able to accommodate pre-hearing conferences with defendants in custody.

Chester Crown Court have indicated that no trial will take place while the Government lockdown is in operation. Those with cases listed as trials at Chester must assume the case will be listed for a mention hearing. Any defendants on bail will not attend court personally for such mentions but arrangements should be made to allow them to appear by SKYPE if possible. Defendants in custody will appear via PVL.
