# Accident Reconstruction "Making the Connection"

Collision investigators have been using physics-based calculation methods as a way of determining the parameters associated with road traffic incidents or over 70 years. In the last 20 years

data has become available from other sources such as digital CCTV and dashcam footage. In the last 10 years manufacturers have provided data from the vehicle airbag control module (on request in criminal proceedings). We are now at a point where vehicle computers are extremely sophisticated. The issue has, until recently, been how to access this (potentially) useful data. As of 2020, collision investigators can now access data from not only the vehicle's airbag control unit and from diagnostic tests, but also from the 'infotainment' system. This presentation aims to explain what data is available, how we can access the data, how reliable/accurate it is, and what it can be used for.
